SPECIAL DAYS
AT THE
PAN-AMERICAN

THE week beginning Sept. 15
will be Lumbermen's week
at the Pan-American Expo-
sition. Thousands of whole-
sale and retail dealers in
lumber from all parts of the United
States and Canada will be at the great
New World's Fair, and they promise
to make the week a memorable one.

One of the organizations which will
be well represented is the Concatenated
Order of Hoo-Hoo, which has a
membership of upward of 8,000.

The annual meeting of the Hoo-Hoo
will be held at Norfolk, Va., from
Sept. 9 to 13, and the delegates will go
direct from the Southern city to the
Exposition.

The Concatenated Order of Hoo-Hoo
is essentially a lumbermen's order, be-
ing composed of lumbermen, timber-
men, saw and planing mill machinery
manufacturers, newspaper men and
railroad men, being those engaged in
the lumber trade and those allied in-
dustries which are so closely interwoven
with the conduct of the lumber
business as to make them practically a
part thereof.

Mexico Day, Sept. 16.
Exceptional ceremonies are being
planned for Mexico day, Monday, Sept.
16, at the Pan-American Exposition.
Dr. Aspiroz, the Mexican ambassador
to the United States, will be there and
will speak. In addition, it is proposed
to have a famous and eloquent states-
man and orator from Mexico make the
address of the day. An effort is being
made to secure the attendance of Chief
Justice Justo Sierra of the Supreme
Court of Mexico. It is proposed to
bring the famous Mexican Artillery
Band to the Exposition for the day.
The Mexican commissioners to the Ex-
position are deeply interested and will
strive earnestly to make their repub-
lic's special day a memorable one.

Illinois Day, Sept. 16.
Among other prominent speakers at
the Pan-American Exposition on Illi-
nois day, which will be Sept. 16, will
be Secretary Lyman J. Gage, Senators
Shelby M. Cullom and W. E. Mason,
Comptroller of the Currency Charles
G. Dawes, in addition to Governor
Richard Yates. The First Regiment of
Chicago will be in attendance, and the
social features of the occasion will not
be slighted, an informal hop at one of
the large hotels in Buffalo being in-
cluded in the plans.

Grand Army Veterans' Day, Sept. 17.
G. A. R. day at the Pan-American
Exposition, Tuesday, Sept. 17, will be
one of the truly great days of the season.
It follows closely the national
encampment, which is to be held at
Cleveland, and many thousands of vet-
erans and their families will embrace
the opportunity of viewing the won-
derful sights at the great New World's
Fair. An elaborate programme ap-
propriate to the occasion will be car-
ried out. Numerous special features will
be provided in honor of the visit of the
veterans. Among the bands which
will be at the Exposition on G. A. R.
day are Brooke's Marine Band of Chi-
cago, Nineteenth Regiment Band of
St. Catharines, Ladies' Military Band
of Boston and the John C. Weber Mil-
itary Band of Cincinnati. Band con-
certs will be given forenoon, afternoon
and evening. There will be a tree or-
gan recital by Seth C. Clarke of Buf-
falo in the Temple of Music in the af-
ternoon. In the evening there will be
one of the most magnificent displays
of Paine's fireworks ever seen. The day
will be one long to be remembered.

New York State Day, Sept. 18.
New York State day at the Pan-
American is Sept. 18, and an effort will
be made to eclipse all previous records
for attendance on that day. Low rail-
road rates will be obtained from all
parts of the State, and there will be a
large gathering of public men, politi-
cians, orators and distinguished citi-
zens, besides members of the National
Guard. The principal orator of the
day will be the Hon. St. Clair McKel-
way, editor of the Brooklyn Eagle and
one of the most brilliant orators of the
State. It is expected that the guests
of the day will include Senator Thomas
C. Platt, Senator Chauncey M. Depew,
Governor B. B. Odell and staff and the
Adjutant General of the State. General
George F. Roe. There will be a big
military display, including prob-
ably all the National Guard regiments
and companies of Western New York.

Welsh Day and Elsteddoff, Sept. 19.
The Elsteddoff at the Pan-American
Exposition on Sept. 19, which has been
designated as Welsh day, will be a
very important musical event. The
leading Welsh soloists and choirs will
compete for prizes aggregating \$1,000.
The sons and daughters of Wales in
this country are deeply interested in
Welsh day and the Elsteddoff, and
many thousands will visit the Expo-
sition for the festivities. The Elsteddoff
will be held in the magnificent
Temple of Music of the Exposition,
which contains the finest pipe organ in
America.

The Welsh are pre-eminently mu-
sical vocally, and they are second to
no other people for choral singing. Within
easy radius of Buffalo there are thou-
sands of Welsh singers. Half a dozen
fine choirs will be organized to take
part in the contests. This will furnish
also a rare opportunity and stimulus
to the Welsh choral community to
show the people of all America what
they can perform in the line of choral
music. The chief competition will be
"God So Loved the World" (Sir J.
Stainer) and "We Never Will Bow
Down" (Händel), \$400; also male
chorus contest, "Song of the Pilgrim"
(Morris), and a female chorus contest
"Lullaby" (Brinley Richards). The fol-
lowing will be the adjudicators: Wil-
liam Appando, Chicago; Edward
Broome, Montreal, Canada; John Lind
of Buffalo, N. Y. The presidents of
the day will be Rev. D. Rhoslyn
Davies of Allegheny, Pa.; Hon. Ellis

Oregon Day, Sept. 25.
In Oregon everything that happens is
on a big scale. Evidence of this is
seen in the exhibition buildings of the
Pan-American Exposition. The State's
exhibit is one of the most complete and
interesting at the New World's Fair.
All who view it pronounce it highly
creditable to the productive and pro-
gressive State. The plans for Oregon
day at the Exposition are on a scale
characteristic of the State. The chief
officers of the State, representatives in
the National Legislature and other
prominent organizations will partici-
pate in the exercises. Sept. 25 is the
day set aside for Oregon day.

Cleveland Day, Sept. 26.
The enterprising city of Cleveland
will have a holiday on Thursday, Sept.
26, which has been designated as
Cleveland day, at the Pan-American
Exposition. Arrangements will be
made for low rate excursions both by
rail and water, and many thousands of
the Forest City's citizens are expected
to make the trip to the Exposition,
where a programme of exercises ap-
propriate to the occasion will be car-
ried out. The Mayor and other city of-
ficials will deliver addresses. Disting-
uished Ohio statesmen will be invited
to participate in the exercises. The ar-
rangements for the event are in the
hands of committees composed of
Cleveland's most prominent and influ-
ential men, and success is assured.

Nebraska Day, Oct. 2.
Nebraska has a fine exhibit of its
products at the Pan-American Expo-
sition, and the State is to further dis-
tinguish itself by the observance of a
special day at the Exposition. Oct. 2 will
be Nebraska day, and a programme in
which the most distinguished men and
women of the State will take part is
being arranged.

**New York Federation of Women's
Clubs.**
Wednesday, Oct. 9, has been set aside
as special day for the New York Fed-
eration of Women at the Pan-American
Exposition. The annual convention of
the Federation will be held in Buffalo
Oct. 8 and 9. Usually at the annual
meeting several entertainments are
given in the evening, but this year the
entertainments will be limited to two,
an opening reception given by the
Women's Union and a closing recep-
tion to the Federation given by Mrs.
Hamlin, president of the Women's
Board of Managers of the Pan-Ameri-
can Exposition. The programme also
contains but few subjects this year,
the idea being to give more discussion
to each subject and leisure to see the
Exposition and to render the sessions
less fatiguing than they were wont to
be with many subjects.

YACHTS COULD NOT FINISH
Second Constitution-Columbia Trial
Race Off for Lack of Wind.
Newport, R. I., Sept. 3.—The second
official trial race of the Columbia and
the Constitution had practically no re-
sult. The yachts for lack of wind
were unable to finish within the time
limit of 5½ hours. At 6:30 last even-
ing the contest came to an inglorious
conclusion two miles to the eastward
of Brenton's Reef Lightship. At the
time the Columbia led by a good quar-
ter of a mile. Sir Thomas Lipton,
with George L. Watson, the designer
of the Shamrock II.; William Jamieson,
the famous English yachting cap-
tain; Ratsey, the sailmaker, and Cap-
tain Sycamore, of the Shamrock II.,
watched the race with eager interest
from the bridge of the steam yacht
Erin.

Last Sail of the Independence.
Boston, Sept. 3.—The yacht Inde-
pendence, built at a great cost, some
say of a quarter of a million of dollars,
for Mr. Thomas W. Lawson, who hoped
to use her as a candidate for Ameri-
ca's cup honors, and which purpose
failed, went out yesterday for what
was to be her last sail. As the breeze
failed she will have a try today.

No Real Democratic Candidate Out Yet
Kansas City, Mo., Sept. 3.—C. A.
Walsh, secretary of the Democratic
national committee, is here on busi-
ness, and said in an interview yester-
day: "There is no real discussion now
of the candidates for the Democratic
nomination for president in 1904. Of
course, a great many men are talked
about. There is Hill and Olney and
Dockery and Dave Francis and W. J.
Stone and Senator Cockrell, but its a
long time until 1904."

Engineer's Daring Frustrated Wreckers
Fort Worth, Tex., Sept. 2.—An at-
tempt to hold up a passenger train on
the Gulf, Colorado and Santa Fe at
Death Valley, near Guthrie, O. T., last
night was frustrated by the daring
of the engineer. A pile of ties was
placed across the track, which the
engineer discovered, but instead of
stopping, he opened the throttle and
cleared the track of the obstruction.

Sampson Gaining in Health.
Lake Sunapee, N. H., Sept. 3.—Ad-
miral Sampson, who, it has been re-
ported, is dangerously ill, was on the
lake the greater part of the day and
chatted with his friends on the hotel
veranda after his return. He remains
in his room but little, and the hotel
people declare he is steadily gaining
in health.

Shooting Shrouded in Mystery.
Huntsville, Utah, Sept. 3.—Robert
Graham, a well-known citizen of Weber
county, and a prominent official in the
Mormon church, was shot and almost
instantly killed while returning home
from church last night. The affair is
shrouded in mystery, as there is no
clue to the perpetrators of the deed.

Adams Democrats Name Officers.
Gettysburg, Pa., Sept. 3.—The Dem-
ocratic convention of Adams county
yesterday nominated William E. Kapp,
of Butler township, for probate; John
Unger, of Littlestown, for direc-
tor of the poor, and Daniel P. Delay,
of Biglersville, for county surveyor.

Swimmer McNally Sighted.
Boston, Sept. 3.—Peter McNally,
who has his mind made up to swim
from Boston to New York, and who
started on Sunday afternoon, was
passed by incoming craft at 2:30 p. m.,
a mile inside of Boston light.

Carnegie's Gift to Brave Miners.
London, Sept. 3.—Andrew Carnegie
has given \$500 each to Sheldon, Law,
Jones and Oick, four miners who dis-
played conspicuous bravery in the
rescue of their comrades at the time
of the recent Dolinbriestle, Perthshire,
colliery disaster.

Oyster Season Opens Auspiciously.
Baltimore, Sept. 3.—The oyster sea-
son opened auspiciously yesterday in
this state. At least 20 pungies are ex-
pected in port today with many bush-
els of bivalves as a result of the work
yesterday. Eighty-five cents a bushel
is the prevailing price.

Ho Yow to Succeed Wu Ting Fang.
San Francisco, Sept. 3.—It is re-
ported here that Consul General Ho Yow
will be appointed to succeed Minister
Wu Ting Fang if the latter is trans-
ferred to London.

McCLURE'S GAME
An Old Politician's Desire For Re-
venge Upon Republican Leaders.

TO HOLD BOLTING CONVENTION
Wanamakerism Called Upon To Help
Out a Desperate Attempt To Injure
the Candidates on the Republican
State Ticket.

(Special Correspondence.)
Philadelphia, Sept. 3.—Colonel Alex-
ander K. McClure, who has been a
member of every political party that
has had an existence during the last
half century, excepting, of course, the
Prohibition party, has determined to
hold an independent state convention
in this city on the 12th of September.
Colonel McClure is just now on the
rampage and is out for revenge. He
is disgruntled because the Republican
organization of this city refused to
renominate his brother-in-law, Simon
Gratz, for the lucrative position of
member of the board of revision of
taxes. Mr. Gratz has been a member
of this board for a number of years
and under his administration there
have been many complaints regarding
the discriminations in favor of the
wealthy classes in the assessments of
real estate for the purpose of taxation.

WHY McCLURE KICKS.
The Republican leaders of this city
determined to reform present condi-
tions and they had a bill passed at the
last session of the legislature repeal-
ing the act under which the members
of this board were appointed by the
board of judges, and requiring that
these positions shall, hereafter, be
filled by elections by the people.

McClure was intensely disappointed
over this move and he swore ven-
geance against the Republican party
leaders in this city and in the state.

He had been potted and favored by
the Republican organization for a
number of years and he seemed to
have gotten the idea that he must
have everything he wanted without a
question being raised.

A CASE OF BROTHER-IN-LAW.
Another brother-in-law of McClure,
Alfred Gratz, almost cost the Republi-
can party the loss of the office of
register of wills some years ago when
he was forced upon the Republican
party as its candidate by the late
James McManes, to oblige McClure,
who was, at that time, at the head
of the Philadelphia Times, and who
worked all parties to accomplish his
personal ends.

There was a popular revolt against
the Gratz nomination and he only won
out at the polls by the aid of Demo-
crats who believed in McManes and
who sold out their party nominee and
gave Gratz his election by a miser-
able plurality of less than 2,000, when
any strong candidate should have had
40,000 majority at least.

Now, McClure, although it is about
time for him to retire from the po-
litical arena, demands the re-election
of his second brother-in-law for the
board of revision of taxes in this city,
and because the leaders of the Republi-
can organization have determined to
shut off the McClure income from the
Republican party he proposes to join
hands with the remnants of the old
insurgent organization, and have a
state convention all to himself, with
Wanamakerism supplying the funds
to finance the game, and seek to cut
down the Republican majority in the
coming state campaign.

McClure is the chairman of the so-
called "Union party's" subcommittee
which is running the independent
movement in the state, and George
E. Mapes, an old time Cleveland sup-
porter is secretary of the committee
which has the matter in charge and
which is looking after the transporta-
tion of small fry and disappointed
politicians, who are willing to come
here and figure in an independent con-
vention provided their railroad fare is
paid, and they are given money to pay
their board and meet other "necessary
expenses."

TO BE A PACKED CONVENTION.
The original proposition was to hold
this independent convention in Har-
risburg, but when a canvas of the
state disclosed the fact that it would
be impossible to get any number of
representative men to attend such a
gathering from the interior counties
the plans were quickly changed and
it was determined to seek the aid of
the Wanamaker contingent in this
city and to have them hire enough
men to make a fairly good showing
at the so-called convention.

It is known that arrangements have
already been made to get a large num-
ber of politicians who have been dis-
missed from various departments in
this city to go as "delegates" to this
fake convention and to endeavor to
make it appear that there is a great
popular sentiment against the Republi-
can ticket.

There will not be one per cent. of
the men in this convention who will
not be there for a selfish and personal
interest and who will not hope to gain
something through the defeat of the
Republican party.

TO NAME A DEMOCRAT.
There is no indication that there
is to be any change from the original
program for the nomination of the
Democratic candidate for justice of
the supreme court, Judge Yerkes, for
that office, and the selection of E. A.
Coray, a Wanamaker insurgent of Luz-
erne for state treasurer. The Mc-
Clure crowd still want to have the
Democratic candidate for state treas-
urer, Representative Palm, withdraw
from the fight in order that they may
have Coray's name placed upon the
Democratic ticket, but it is not believed
that this can be accomplished.
