Deserves Serious Thought.

There were to be an epidemic traceable to the public schools, indignation would reach a high stage. There were to be a panic or a fire, horror accompanied by fatalities, a tremendous outcry would result. Such is the value of the little lives which are entrusted to the public schools for the better part of five out of seven days each week. Such an incident would result in the doing away with unsanitary fire traps and the construction of the best form of fireproof, modern buildings.

But do we have to wait for such a fog to the mentality. It is true that theaters did not have asbestos curtains until after the Iroquois calamity. But we have had the Colliwood school example, and none other is needed. This is perhaps putting it a little. One does not desire to prophesy disaster. But any one who thinks it is not of importance should personally visit the Dale school, look at the stairways, walls and floors, talk with the teachers and pupils, and from the topmost floor figure what should be done if a panic comes.

The proposition to raze this building and replace it with the larger, more modern structure that is so badly needed, comes up tomorrow. It is therefore well to think of these things. The board of education has pointed to a solution of the difficulty; it is up to the public to sanction it by their votes.

Under the Surface.

Cleverness some times over steps the mark. The prohibition question raged in Missouri this summer, there being considerable question as to what the legislature would do on the subject. The state is the home of some of the largest brewing interests in the country, so there was much interest expressed. A portion of this interest manifested itself in some attractive display advertising in the newspapers, and one of the latter portrayed half a dozen men, dressed in the garb of different employments, toasting, with uplifted glasses, a certain brand of beer which enjoys a world wide reputation.

It was a striking ad, and a good one if not analyzed too closely. The man on the extreme left held a long nosed oil can in one hand and wore the cap, jumper and overalls of a railroad engineer, while his vis-a-vis on the extreme right wore the safety belt and jagged spurs of the electric lineman. The awkward point is this, that there is not a railroad in the United States that would stand for an engineer such as was pictured, and very few of the electric companies permit in their employ for the hazards of high tension wires and tall altitudes, linemen who drink toasts to Gambrinus.

Probably is Wrong.

J. H. Truesdale, editor and publisher of the Gazette-News at Bunker Hill, says editorially in today's issue of his paper: "Saturday we were twenty years married and are ready to die. Instead of receiving presents of china we wish we were in a country of that name."

Inasmuch as the editor somehow received the impression that the prohibition ticket was defeated in Edwardsville last month when the wet and dry proposition was not even thought of here, it is but reasonable as well as charitable to believe that he is about as much in error on the subject whereof he speaks today.

There is no way to prevent a board of school directors from granting the temporary use of a school house for religious purposes when the school is not in session, as the matter is vested in the discretion of the board.

Six calendar months within the school year, from July 1st to June 30th, is the shortest term of school a district may maintain and be entitled to receive its share of the state and township distributive fund.

SENATE DASHES
CHARTER HOPESMotion to Reconsider Lost
by Vote of 26 to 21.

VICTORY FOR LIQUOR MEN

House Passes Measure Which Provides That Cities and Towns May Settle For Themselves Question of Local Option Regardless of Elections Held in Townships in Which They Are Located—No Change in the Deadlocked Senatorial Situation.

Springfield, Ill., May 20.—The knell of Chicago charter prospects was sounded in the senate when, by a vote of 21-26, the upper house refused to reconsider the vote by which the first charter bill was lost last week. The funeral rites were short, the vote being taken after a few words from Senator Curtis, chairman of the charter committee.

"The present system of government is inadequate," said Curtis. "There is no opposition to this bill and the votes against it are on account of the desire of the country members to restrict representation from Cook county. I hope the bill will pass."

The motion to reconsider was then put and lost.

Although morally certain that charter bill No. 1, otherwise known as the charter consolidation bill, entitled house bill 350, would be defeated if called up in the house after it had lost in the senate, Representative Kittelman presented the bill for passage. The measure vests in the city government of the city of Chicago all the powers of the other municipalities within the city limits, such as the school board, the park board and the library board and also increases the bonding power of the city by approximately \$25,000,000. Kittelman spoke at length in favor of the bill.

The roll call showed that the bill was lost by a vote of 34 yeas to 38 nays.

The senate reconsidered the vote on Senator Breidt's bill abolishing the indeterminate sentence and took up the question of passing it over the governor's veto, which requires 34 votes.

Governor's Veto Sustained.

The bill was declared by Attorney General W. H. Stead to be unconstitutional. A contrary view is taken by State's Attorney John E. W. Wayman of Cook county and other state's attorneys. By a vote of 22-18 the bill failed to pass over the governor's veto.

The saloon forces won a victory in the house with the passage of the city local option act which separates cities, villages and incorporated towns from the remainder of the township. The vote was 78 for the bill and 70 against it. The constitutional majority of the house is 77 votes.

A motion to reconsider was quickly tabled. The bill must now run the gauntlet of the senate and receive the approval of the governor before it becomes a law.

Measure Defines Intoxicants.

In addition to declaring that municipalities shall not be governed by the country vote on the saloon question the measure defines intoxicants to be liquor containing one-half of 1 per cent of alcohol.

The bill known as the osteopaths' bill, providing for the appointment of a board of examiners of osteopaths, was lost in the house.

The Gilbert practice act, which revises completely the forms and procedures in legal practice, passed the senate without a single vote to spare.

An employers' liability bill, which destroys in effect the fellow servant act, went through the house with flying colors.

The measure regulates the liability of companies for damages to employees by providing that employees who contribute to the wrongful act shall be equally liable for damages with the employer. In this it nullifies the present act on contributory negligence. The measure also nullifies all contracts of employment which release the employer from responsibility for personal injury.

In explaining his vote for the bill, Representative E. J. Murphy displayed an empty coat sleeve and said:

"Being a victim of this fellow servant act, it is a pleasure to me, after waiting eight or ten years, and being cheated out of what rightfully belongs to me, to vote aye."

New Game Law Passed.

The new game law was passed by the house by a vote of 116 yeas to 13 nays. Other bills were passed as follows:

Prohibiting the erection of bill boards within 500 feet of a public park or boulevard in cities of 100,000 population and requiring removal of existing bill boards; providing that city councils and presidents and trustees of villages and townships be given power to license and regulate bill and sign board advertising; making the salary of members of the railroad and warehouse commission and the secretary of the commission \$3,500 per annum.

For Traction Consolidations.

The house committee on railroads

reported out with a favorable recommendation house bill 410, which permits electric interurban railroads to make traffic agreements and consolidation with other electric railway companies.

The house committee on sanitary affairs gave favorable consideration to bills providing for the issuance of licenses to internos prior to the issuance of a regular physician's license by the state board of health; amending the practice act by classifying under what conditions graduates of osteopathic colleges may be granted licenses, and providing for licensing itinerant vendors of medicines at \$100 a month, the act not to apply to the sale of patent medicine in original packages.

Provides For Civil Service Boards. Other bills were passed in the senate as follows:

Providing that after 1910 the superintendent of public instruction of Cook county shall buy all supplies and food for the county jail; raising the salaries of clerks of the circuit, superior, criminal and probate courts and of the coroner of Cook county from \$5,000 to \$9,000, without fees, and providing for county civil service boards of three members at a salary of not less than \$3,000 per year.

A bill for the sale of 16.75 acres of land to the American Smelting and Refining company for \$1,675 was introduced in the senate.

BREAD IS 15 CENTS A LOAF

Price Raised Owing to Strike of Bakers in New York.

New York, May 21.—The closing down of 100 bakeries on the east side, coincident with the strike of the bakers' employees, has caused the price of bread to increase to 15 cents a loaf.

The strikers, in an effort to prevent a bread famine, discussed the feasibility of starting co-operative bakeries to relieve the distress.

TROUBLE ON GEORGIA ROAD

Firemen on Trains Beaten and Intimidated by Strikers.

Augusta, Ga., May 21.—There have been acts of violence on the Georgia railroad following the firemen's strike. Firemen on freight trains have been beaten and intimidated. Firemen on mail trains on the Athens and Macon branches have been intimidated and mails delayed.

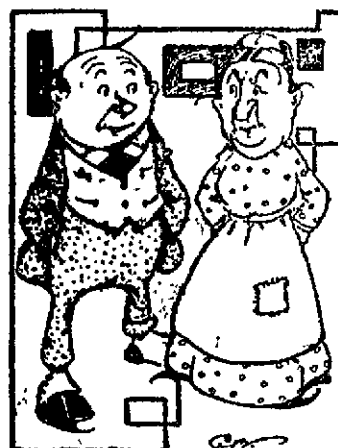

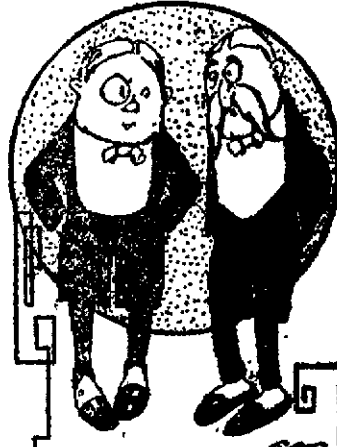
