

SENATOR ELKINS DEAD AT AGE OF 69

Passes Away at Washington
After Long Illness.

WAS IN SENATE SINCE 1894

Served as Secretary of War Under
President Harrison—Leaves an
Estate Amounting to
\$30,000,000.

Washington, Jan. 5.—Senator Stephen B. Elkins of West Virginia, son-in-law of Henry Cassaway Davis, Democratic candidate for vice-president in 1904, and himself a Republican leader of the senate, died early today at his Washington home after an illness of nearly a year.

Doctor Sowers, who attended the senator, announced the cause of his death as septemia. All the members of his family were at the bedside when the end came, as his demise had been expected for several days.

No arrangements have been made for his funeral, but it is probable it will be held at Elkins, W. Va.

Senator Stephen Benton Elkins was born in Perry county, Ohio, September 26, 1841. He received his early education in the public schools of Missouri and graduated from the Missouri State university at Columbia in the class of 1860. He was admitted to the bar in 1864, and in the same year went to New Mexico.

He made his debut in politics as a member of the territorial legislative

assembly of New Mexico in 1864-5, where his commanding presence and magnetic force gained him many friends.

In 1867 he became attorney general for the territory, and a year later was made the government's attorney for New Mexico by Andrew Jackson.

He continued in that capacity through the presidential administration of General Grant. While holding this position he was instrumental in passing and enforcing a law against "peonage," a form of slavery in New Mexico.

Amasses Large Fortune.

It was at this period of his career that he commenced to amass his great fortune. In 1869, at the age of twenty-eight, he was elected president of the First National bank of Santa Fe. His investments prospered to such an extent that his name became a byword in financial circles.

In 1873 he went to congress as territorial delegate. While at Washington he married the daughter of Senator Cassaway Davis, from West Virginia. Mr. Elkins was re-elected to the Forty-fourth congress while on a trip to Europe, and at the same time became a member of the Republican national committee, on which he served for three presidential campaigns.

At the end of this period he left congress and moved to West Virginia, where he devoted himself to business affairs, making lucrative investments in the neighboring coal lands.

In December 17, 1891, he was appointed secretary of war and served in that capacity till the close of President Harrison's administration.

In February, 1891, Senator Elkins surprised and startled his countrymen by announcing to the United States senate that he was resigning his seat in the senate, and was seeking to be elected to the United States senate. There was a great deal of speculation as to the reasons for his resignation, but he himself declared that he was doing so in order to be able to devote his entire time to his business interests.

FLYER HELD UP BY BANDITS

TWO LOOT MAIL CAR AND SHOOT
DOWN CLERK.

Robbers Board Northern Pacific Train
at Seattle—Make Away With Un-
known Amount of Loot.

Auburn, Wash., Jan. 5.—Two masked bandits entered the mail car on the Northern Pacific railroad just as the train was leaving the King street depot, Seattle.

As soon as the first robber got in the door he leveled his revolver at Mail Clerk Harry O. Clark and ordered him to throw up his hands, and then fired before Clark could obey the demand. The bullet struck Clark in the mouth, ripping out the teeth on one side.

As soon as Clark fell the two robbers turned their attention to the other clerk, C. E. Reid, and covered him.

Both Clark and Reid were then locked up in a closet in the end of the car and were not discovered until the train reached Auburn.

A large consignment of Tacoma and south mail is transferred to this train at Auburn.

The train does not stop between Seattle and Auburn, but the robbers got off at Kent, where the train slows up for the city limits.

According to Reid the two robbers wore masks over the lower part of their faces.

The mail pouches and registered mail were scattered in the car, but it could not be learned what had been taken.

TROOPS SLAY 18 BANDITS

Heavy Fighting at San Felipe, Mexico
—Large Quantity of Ammunition
and Supplies Captured.

Mexico City, Jan. 5.—Eighteen bandits and three soldiers were killed in a fight at San Felipe, state of Tabasco, Sunday, according to official dispatches which reached Mexico City. The telegrams were sent by messenger to a telegraph office 50 miles from the scene of the fight. The report stated that ten soldiers and many bandits were wounded. For several weeks a band of 300 men has been making trouble for the authorities in Tabasco. They claimed to be revolutionists, while the government authorities say they are not connected with any revolutionary movement, but organized themselves into a clan to plunder.

The troops were ordered to attack them Sunday at San Felipe, where a sharp engagement lasting two hours and twenty minutes occurred. Sixty bandits surrendered at the close of the encounter, the others scattering in all directions to the mountains pursued by soldiers. The troops captured a large quantity of ammunition and a number of horses and guns were left in the town by the members of the band.

BANK HAS RECORD SURPLUS

Union Trust Company of Pittsburgh
Has \$27,500,000—Stock Quoted
at \$1,834.

Pittsburgh, Pa., Jan. 5.—The Union Trust company of Pittsburgh, in which Secretary of State P. C. Knox, H. C. Frick, A. W. Mellon and Henry Phipps are directors, has announced the addition of \$1,000,000 of last year's profits to the bank's surplus, making a surplus of \$27,500,000—perhaps the largest of any bank in America. In addition to this, this bank paid out dividends of \$1,000,000 on earnings for the year 1910. The bank's stock is now quoted at \$1,834 for each share par value of \$100.

ASKS FRANCHISE FOR WOMEN

HUNDREDS KILLED BY ASIATIC QUAKE

Vyerny, in Russian Turkestan, Is
Devastated.

FORTY BODIES RECOVERED

Shock of Disturbance Which Destroys
Inhabitants and Wrecks Cities Felt
Throughout World—Czar Sends
Aid to Stricken.

St. Petersburg, Jan. 5.—Reports of the effect of the terrific earthquake that shook Russian Turkestan are beginning to be received here from the stricken districts by the government officials, and all tell tales of death and destruction.

Forty bodies have been recovered from the ruins of the city of Vyerny, where the shake was most severely felt. Vyerny is a fortified town, situated at the northern foot of the Trans-Ili Ala-Tau, about fifty miles from the river Ili, and about the same distance from Lake Issyk-Kul, and from the reports received was the center of the disturbance, which was felt around the world.

Great Fissures Opened.

At Vyerny great fissures opened in the ground, and in some cases entombed entire houses before the occupants could escape. A gigantic crack several feet in width extends across the entire market place of the city. From this apparently radiate other cracks which, according to the frightened natives, opened wide enough to consume the houses and then closed to their present size.

The terror-stricken inhabitants gathered around the governor's house and united in praying for deliverance. With each succeeding shock their terror increased. Men, women and children were speechless with fear and stood rooted to the ground with fright.

At Tashkent, capital of the general government of Russian Turkestan, the shock was so severe that a number of buildings collapsed, burying a number of people in the ruins. The exact loss of life is not known.

Communication Cut Off.

Telegraphic communication with Vyerny is cut off entirely and the only information that can be received is by messengers from the stricken city to the neighboring towns, from whence it is possible to send messages to this city.

Preparations are being made here to send aid to the destroyed district, for what with the intense cold and the lack of food the suffering must already be intense.

Earthquake shocks are not unfamiliar to the residents of Turkestan in the vicinity of Vyerny, as it was badly damaged by a disturbance of the earth in 1897.

Tremors Recorded in America.

Washington, Jan. 5.—Earthquake shocks of unusual intensity and duration were recorded by seismographs in this city, New York and Cleveland.

London Feels "Gigantic" Shock.

London, Jan. 5.—An earthquake of moderate intensity was recorded by the British seismograph at Greenwich, and was felt in London, and in the surrounding districts. The earthquake was so violent that the ground in the neighborhood of the instrument was broken.

EIGHT DEAD IN RAIL WRECK

NORTH COAST LIMITED HITS
BURLINGTON COACH.

Trainmen and Passengers Are Ser-
iously Injured in Accident on North-
ern Pacific Near Spokane.

Spokane, Wash., Jan. 5.—In the Northern Pacific yards in Cheney, North Coast Limited No. 2 struck the rear car of Burlington passenger train No. 42, east-bound. Three coaches were wrecked.

Eight are believed dead and a number of trainmen and passengers seriously hurt.

The engineer and fireman of No. 2 and the express and mail clerk are missing and are believed to be dead in the wreckage. The Burlington train was taking the siding to let the limited pass.

A relief train with physicians and nurses left Spokane at once for the scene.

Five dead have been found, and it was reported that eight more bodies were in the wreck. The known dead are:

—Oliver, porter, Chicago.

—One unidentified man.

A Pullman porter, name unknown, is injured fatally.

CELL FOR GAYNOR ASSAILANT

James J. Gallagher Is Sentenced to
Twelve Years at Hard Labor
for Assault.

New York, Jan. 5.—Twelve years at hard labor in the prison, "and thence until the cost of prosecution is paid," was the sentence pronounced on James J. Gallagher, who shot Mayor Gaynor, in the court of oyer and terminer in Jersey City.

Having been adjudged sane, Gallagher was put on trial on the charge of atrocious assault on Street Commissioner "Big Bill" Edwards on board the liner Kaiser Wilhelm der Grosse on August 5 last. The verdict was returned in 40 minutes.

No testimony was offered in the defendant's behalf. Attorney Simpson resting his case with the request that the charge be dismissed on the ground that no intent on Gallagher's part to kill Edwards had been shown.

ROB 30 BANKS IN 90 DAYS

Kansas Bandits Loot One Every Third
Day, and No Thief Is
Caught.

Topeka, Kan., Jan. 5.—Bank robbing appears to be one of the most profitable industries in Kansas. Figures made public here show that in the last three months 30 banks have been robbed in the Sunflower state. These robberies have netted the robbers \$100,000.

And the industry appears no less safe than it is profitable. Not one robber is in jail as a result of all these raids.

J. N. Bailey, state bank commissioner, says there are two bands of these robbers, one with headquarters in Nebraska and the other in Oklahoma. These bands appear to understand each other, as one does not infringe on the territory of the other.

Hung American Pensioner at Cork.

Cork, Ireland, Jan. 5.—William Shankan, an American army pensioner, was hanged for the murder of his sister-in-law. The crime was committed in 1907, and Shankan, who had three trials, was convicted on purely circumstantial evidence.

ILLINOIS SENATE OUSTS HOLSTLAW

Colleagues Vote to Expel Con-
fessed Bribe Taker.

LORIMER CASE TO BE PROBED

Charles Adkins Is Elected Speaker of
House and Is Supported by
Twenty Members Who Bolt
Party Caucus.

Springfield, Ill., Jan. 5.—Expulsion of Senator D. W. Holstlaw of Iuka, self-confessed bribe taker, from the senate of Illinois was the feature of the convening of that body.

This action was expected to go far in the precluding of an extended investigation by the senate of the Lorimer scandal, in which Senator Holstlaw confessed he received \$2,500 for his vote, although a resolution was later adopted naming certain senators to conduct an inquiry into charges of bribery and corruption. Holstlaw also confessed receiving \$700 from the alleged "jack pot."

Oglesby the Moving Spirit.

Expulsion of Senator Holstlaw was engineered by Lieut. Gov. John G. Oglesby. When the name of the senator was reached on the roll call of the hold-over senators, the lieutenant governor, as presiding officer of the upper house, directed that it be omitted. The reading clerk hesitated for a moment as a sudden hush fell upon the senate.

With hardly a second's hesitation Chairman Oglesby handed to the clerk the formal resignation which Senator Holstlaw had sent to James A. Rose, secretary of state, from his Iuka home, when his confession added fuel to the big legislative scandal last summer. As the reading of the resignation was finished Senator Douglas W. Helm was on his feet with a resolution declaring vacant the seat which Senator Holstlaw had occupied.

The chair ruled that the resolution lie on the table for one day.

Will Lose His Salary.

Expunging the name of Holstlaw from the senate roster means that the Iuka banker will not collect the \$2,000 salary which will be paid to each of the other 50 senators before he leaves Springfield this week.

Stanton C. Pemberton of Oakland, involved in the furniture scandal and under indictment in Sangamon county, added to the sensation by reading a statement asking that he be excused from all participation in the senate's activities until a committee can investigate the charges.

Asks a Bribery Inquiry.

Senator Dalley of Peoria offered a resolution calling for the appointment of a committee "to investigate the charges of bribery and corruption made against certain members of the senate who have been indicted for or confessed to the crime of bribery, to consider the facts relating thereto and report to the senate their findings and conclusions with respect to such matters and as to whether such senators or either of them should be unseated or expelled from the senate."

The motion was adopted.

Henry M. Dunlap of Savoy and Frank W. Burton of Carlinville, the respective nominees of the Republican and Democratic caucuses, were the two nominees for president pro tem of the senate. The party vote was 34 to 16 in favor of Senator Dunlap.

Adkins Made Speaker.

Representative Charles Adkins of Bement was elected speaker of the Forty-seventh assembly when that body convened. The vote was 84 for Adkins, against 54 for George W. Alschuler, the Democratic choice.

The Republicans united on Adkins after 48 hours of wrangling filled with bitterness. The 20 Shortliff men who bolted the party caucus came into camp on Adkins. The consolation they receive is in the assertion that it was their bolt which forced the selection of Adkins.

George W. Alschuler of Anson was the Democratic caucus nominee for speaker, by virtue of which he was made the minority leader.

Adkins Wins in the Caucus.

On the fifth ballot in a caucus of 62 state administration Republicans Representative Adkins was made the caucus nominee. He was one on a list of men credited as acceptable to the Shortliff men who bolted the caucus of Republicans.

After the fourth ballot in the caucus all withdrew except Adkins, Hamilton, Province and Alschuler. The latter two had been receiving one vote each in the previous ballots. Roll call on the fifth ballot showed that Adkins was elected by a generous majority before the result was announced. Hamilton thereupon withdrew in his favor.

CLAIMS HE IS RESURRECTED

Iowan Asserts He Promised the Lord
to Devote His Life to
Religious Work.

Des Moines, Ia., Jan. 5.—Mark Fitzgerald, a farmer near Truro, claims he has been raised from the dead. He declared that while his soul was in heaven he promised the Lord if permitted to return to earth he would devote his entire time to religious work. He is selling his stock and preparing to devote himself to religious work as he promised. He is forty years old, prominent and wealthy.

STEAMSHIP TRUST IS SUED

THIRTEEN ATLANTIC CARRIERS
ACCUSED OF PLOT.

Government Alleges \$55,000,000
Year in Steamer Business Is
Tied up by Pact.

New York, Jan. 5.—The federal government brought suit in the United States circuit court under the Sherman anti-trust law against 13 of the principal transatlantic steamer lines, which are estimated to control 90 per cent. of the steamer traffic, worth to them \$55,000,000 a year.

Twelve officers of the defendant companies, all resident in America, are named as co-defendants.

These 13 companies, the government charges, entered into an illegal contract on February 5, 1908, in London, by which they constituted themselves the Atlantic conference, with power to apportion all traffic pro rata, impose heavy fines on members of the conference for violation of any of the articles of agreement, and wage competition against all lines outside the conference.

As a result, it is alleged, the Russian volunteer fleet, plying between New York and Libau, was driven out of business, and the Russian-American line was forced to make terms with the conference and enter its membership.

Suit was brought by Henry A. Wise, United States district attorney, acting under instructions from United States Attorney General Wickersham.

In its petition the government prays the court to "enjoin the defendants from further agreeing; combining, conspiring . . . to injure or destroy the business of any person or corporation engaged in the business of carrying steamer passengers between points in the United States and Europe."

FINE ROADS FOR REBATING

Federal Judge Holland Assesses Read-
ing and Lehigh Lines and Bethle-
hem Steel Company \$40,000.

Philadelphia, Jan. 5.—Fines of \$40,000 were imposed on the Philadelphia & Reading railway, the Lehigh Valley Railroad company and the Bethlehem Steel company by Judge Holland in the United States district court for unlawful rebating.

The government charged that the railroads remitted demurrage charges on the freight cars used by the Steel company. The defendants will appeal the case to the Supreme court.
